Communication outlining policies and procedures that contribute to heightened health and safety during a pandemic, including the current Covid-19 Pandemic will increase safety as daily operations continue. Any changes initiated due to government control will be followed and communicated to all stakeholders via telephone, email, social media, and the Fairbarn Electric Inc. website.

Community, Provincial, National and World Health organization links that are relevant sources will be reviewed by Fairbarn Electric Inc. regularly and shared with all stake holders. When changes that effect safety and service are identified by these relevant sources, Fairbarn Electric Inc. will respond as directed and communicate the required protocol and policy changes to all stakeholders including but not limited to employees, customers, sub-contractors, the Electrical Safety Authority and suppliers via telephone, email, social media, and the Fairbarn Electric Inc. website.

Hand washing, social distancing and wiping down commonly used surfaces, are important practices to fight the spread of viruses and these practices will be heightened during a pandemic. At Fairbarn Electric Inc. government approved cleaning agents are used to clean the office, work trucks, tools and all employees hands.

Hand washing and hygiene protocols:

- the office and work vehicles will be cleaned daily using government approved cleaning ingredients
- tools are wiped down with government approved cleaning ingredients daily
- employees are to wash their hands often with soap and water for at least 20 seconds, especially after using the washroom and when preparing food
- use alcohol-based hand sanitizer if soap and water are not available, this is available in each work vehicle
- when coughing or sneezing: cough or sneeze into the bend of your arm, not your hand
- dispose of any tissues you have used as soon as possible in a lined waste basket and wash your hands afterwards and wipe down any surfaces touched between the time of the sneeze and washing of your hands. Use a government approved cleaning product
- avoid touching your eyes, nose, or mouth with unwashed hands
- employees will wash their hands with hand sanitizer each time they enter and exit the work vehicle
- employees will wash hands with soap and water after entering the office and prior to exiting the Fairbarn Electric Inc. office site
- If Personal Protective Equipment is required by a contractor within their work site, the contractor must ensure that this is due to company regulations not threat of exposure to the Covid-19 virus
- If an employee feels any threat of exposure to the Covid-19 virus they vacate the work site immediately and report this via telephone call to the site manager who will then report to the office manager.

Social Distancing protocols:

Social Distancing can help to prevent the spread of viruses, this includes leading a lifestyle outside of the work place that respects this policy as well.

- stay home when you are sick

- avoid large crowds at all times
- leave the job site immediately if someone on the site has presented as visibly ill
